Initial review of the application will be conducted by the HBA's Applications Committee. Final approval or disapproval shall be made by a majority vote of the members of the Association's Board of Directors.

CRITERIA FOR DENIAL OF MEMBERSHIP (ANY ONE OR MORE OF THE FOLLOWING):

- (A) Failure to provide required data
- (B) Background check indicates financial instability (unexplained judgments or liens against firm or individual in past five years)
- (C) Three negative customer references or a record of one legitimate, unsatisfied complaint filed against Applicant with the Better Business Bureau in the past two years
- (D) Negative references from any of the following:
 - a. Supplier
 - b. Subcontractor
- (E) Felony conviction within two years of date of application
- (F) Has not been in the business for at least one (1) year
- (G) Does not operate business within the jurisdiction of the HBA

APPEALS:

- (A) Upon notification of the Board of Director's disapproval of the application, Applicant may immediately reapply for membership or, in a written request, ask the Applications Committee for reconsideration of the application
- (B) After reconsideration, the Applications Committee will forward to the Board of Directors, its recommendation of approval or rejection of the submitted application
- (C) The final disposition to be determined by a majority vote of the members of the Board of Directors
